Subject: ECWA v. Lorich Lorich OWIP # 061956

The above referenced matter concerns a property damage only motor vehicle accident in which a driver struck a fire hydrant resulting in \$28,176.68 damage to Authority property. The driver at fault is a young individual with no assets and no gainful employment. Prior to her departure, Associate Attorney Penberthy reached out to Lorich's private counsel, Patrick Kenney, who assisted in obtaining the full coverage of \$10,000 from the insurance policy and after much negotiation, settled the remaining balance of the claim for an additional \$2,500.00. A release has been sent to Geico Insurance and it is anticipated the payment from the policy of \$10,000 will be received shortly.

It is the opinion of the Legal Department that a judgement against this individual would be deemed uncollectible, and therefore, it is in the Authority's best interest to resolve the matter for \$12,500 offered by the defendant (\$10,000 from Geico and \$2,500 from the defendant, personally).

I would respectfully request that the Board of Commissioners approve settling the outstanding balance of \$28,176.68 for \$12,500.00.
