At the meeting of January 21, 2021, the Board awarded a materials and supplies contract to furnish and deliver water meters and appurtenances effective January 1, 2021 through December 31, 2023 with Neptune Technology Group, Inc. ("Neptune") as well as a subsequent amendment to this contract approved at the November 16, 2023 meeting to extend through December 31, 2024.

In accordance with Article 1, Paragraph 1.04 of the contract and subsequent amendment, the parties may agree in writing to extend the term of the contract for two (2) additional one (1) year terms, under the same terms and conditions or under terms and conditions acceptable to the Authority.

Neptune has submitted a formal letter of request (attached) to extend the contract for the final one-year period from January 1, 2025 through December 31, 2025.

As agreed upon in last year's extension request, the unit prices set forth in the first contract extension remain in effect through December 31, 2025. Neptune's letter of request includes the pricing detail.

The Authority has done business with Neptune for many years. The 2021 contract designated them as the sole source provider of compatible water meters and appurtenances with our current meter inventory. With these factors in mind, it would be in the best interest to extend the contract for the final one-year extension. There is a resolution for the meeting of November 21, 2024 approving the execution of an amendment extending the contract for one final year through December 31, 2025.

WHEREAS, on January 21, 2021, the Authority awarded the Manufacturer a material and supplies contract to furnish and deliver water meters and appurtenances to the Authority for a three-year term (the "Contract"); and

**WHEREAS**, the Contract provided for various water meters and appurtenances to be delivered to the Authority, as ordered, from January 1, 2021 through December 31, 2023; and

**WHEREAS**, in accordance with Article 1, Paragraph 1.04 of the Contract, the parties may agree in writing to extend the term of the Contract for two additional one (1) year terms, under the same terms and conditions or under terms and conditions acceptable to the Authority;

**WHEREAS,** the parties wish to extend the Contract for an additional one-year period from January 1, 2025 through December 31, 2025.

**NOW, THEREFORE,** in consideration of mutual promises herein set forth, the parties agree to the following:

(1) All terms and conditions of the Contract, as amended, shall continue in effect until December 31, 2025; and

(2) This Amendment may be executed in counterparts, each of which is deemed an original, but all of which together are deemed to be one and the same agreement.
