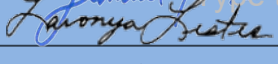

On Tuesday, February 18, 2018, the Authority received two (2) bids for the above referenced contract. The bids have been reviewed, a mathematical check has been performed, and the apparent lowest acceptable bidder is Russo Development, Inc. Enclosed please find a copy of the bid tabulation sheet for your use and information.

We have reviewed the references of Russo Development, Inc. (Russo). In addition to performing satisfactory work in the past for the Authority, Russo is a competent contractor, they have good understanding of the scope and requirements for this contract. The Engineer's estimate for the contract was \$3,611,705.00 and the bid by Russo is \$4,288,867.50.

Two (2) bid items accounted for most of the discrepancy to the Engineer's Estimate, Item 1A – Paving and Item 3B – Concrete. The bid price more accurately reflected the actual cost to the contractor for these items and Russo adjusted their bid accordingly. This change was not foreseen by the Engineer's Estimate.

Russo provided adequate WMBE documentation, approved by Director of EEO (ECWA), insurance, approved by Claims Representative/Risk Manager, and proof of apprenticeship program, approved by Coordinator of Employee Relations.

We, therefore, recommend award of the Area No. 2 Restoration Contract to Russo Development, Inc. in the amount of \$4,288,867.50, subject to legal review.
