In order to boost chlorine residuals within the service area fed by the Pine Hill Pump Station, ECWA would like to inject sodium hypochlorite into the water serviced by the pump station. A precast concrete building is required to house the sodium hypochlorite feed system (metering pump, chemical storage tank, and weight scale). The above referenced contract will allow to place a precast concrete building and associated subgrade/basement on the Pine Hill Pump Station site.
