The work in this contract consists of industrial blasting and painting maintenance, alterations, and/or repairs at the properties owned by or leased to Erie County Water Authority, including: Sturgeon Point WTP, Van de Water WTP, Van de water Raw Water Pump Station, Ellicott Square Building, Service Center, and various pump stations and water storage tanks.

This above-referenced contract is a one-year contract with potential two one-year extensions. The original contract was executed on June 6, 2024, and runs through June 5, 2025. The Authority and the contractor, Niagara Coating Services, Inc., agree that a one-year extension of the current contract from June 6, 2025, to June 5, 2026, under the same terms and conditions would be mutually beneficial for both parties. The Contractor's interest in extending the current contract is expressed in the attached letter dated April 18, 2025.

Niagara Coating Services, Inc. has proven to be a highly capable and reliable contractor whose services are valuable in the operation of Authority facilities. Based on this information it is recommended that the Authority exercise the first one-year extension.





INDUSTRIAL BLASTING, PAINTING, AND
ASSOCIATED MAINTENANCE CONTRACT**

AMENDMENT, effective May 15, 2025, to the Industrial Blasting, Painting, and Associated Maintenance Contract (Contract No. 24-12-06), entered on June 6, 2024, by and between

WHEREAS, on June 5, 2024, the Authority awarded the Contractor the Industrial Blasting, Painting, and Associated Maintenance Contract (the “Contract”); and

WHEREAS, the Contract, executed on June 6, 2024, provides services until June 5, 2025; and

WHEREAS, in accordance with section 00500, paragraph 11.00, subparagraph A of the Contract, the parties may agree to extend the Contract on the same terms and conditions for one year; and

WHEREAS, the Contractor has agreed to extend this Contract until June 5, 2026, based on the same terms and conditions, including but not limited to, labor billed at an hourly rate, at the service rates set forth in section 00410, paragraph 5.01, Item 1 of the Contract; and

NOW, THEREFORE, in consideration of mutual promises herein set forth, the parties agree to the following:

- (1) The terms and conditions of the Contract shall continue in effect until June 5, 2026; and
- (2) The parties agree all other terms and conditions of the Contract shall remain unchanged and in effect; and

(3) This Amendment may be executed in counterparts, each of which is deemed an original, but all of which together are deemed to be one and the same agreement.
