SUBJECT:	Add capital line to unit 1090 - Conversion of old Line Truck 061 to Flat Bed 027

In 2019, ECWA replaced vehicle #V061 as part of our normal vehicle replacement schedule. Vehicle #061 is a 2009 International line truck with 62,133 miles. In an attempt, to auction the vehicle with an asking price of \$11,000, we only obtained one bid for \$3790. We rejected the bid and we are now looking to convert the vehicle into a Flat bed as this would be more cost effective for the Authority. The cost to purchase a new flatbed would be close to \$100,000. Converting this vehicle would cost approximately \$15,000 and it would eliminate us from having to purchase a new flat bed in 2021. This process would not require new funding. We received exceptional bids on our 2020 Meter Shop full size vans that will have fund balances after purchases are completed. I would propose to transfer funds from 3 Meter Shop vehicle capital lines to fund the conversion of V061.

We are requesting approval to amend the capital line budget adding a new line in unit 1090 to purchase and install a flat bed body onto the old truck V061. We are also requesting a transfer of funds from capital lines 101446, 101447, 101448 of \$6000.00 each to the new capital line V027.


