AMENDMENT, effective December 15, 2022, to the Professional Services Contract entered on the December 4, 2019, by and between:

P & A ADMINISTRATIVE SERVICES, INC.

hereinafter referred to as "Service Provider."

WHEREAS, on December 4, 2019, the Authority awarded a professional services contract to the Service Provider for services related to the administration of the Authority's flexible spending accounts for a three-year term, beginning January 1, 2020 (the "Contract"); and

WHEREAS, in accordance with Paragraph 3 of the Contract, the parties may agree in writing to extend the term of the contract for one additional two (2) year term, under the same terms and conditions; and

WHEREAS, in accordance with Paragraph 6 of the Contract, any modification or variation from the terms of the Contract must be in writing, authorized by a resolution of the Board of Commissioners of the Authority (the "Board") and signed by all parties; and

WHEREAS, the Service Provider has agreed to extend the Contract until December 31, 2024, on the same terms and conditions, including pricing as set forth in Paragraph 4 of the Contract;

NOW, THEREFORE, in consideration of mutual promises herein set forth, the parties agree to the following:

- (1) The terms and conditions of the Contract shall continue in effect until December 31, 2024; and
- (2) The parties agree all other terms and conditions of the Contract shall remain unchanged and in effect; and

(3) This Amendment may be executed in counterparts, each of which is deemed an original, but all of which together are deemed to be one and the same agreement.
