SUBJECT:	2022 O&M Budget Transfer Unit 7615, Line Item 78 – Gas, Oil and Grease		

In 2021, the Administration department projected 340,000 for gas, oil and grease based on anticipated 2022 usage and projected costs¹. Unfortunately, the cost for gas increased significantly during 2022 causing a large shortfall in Line Item 78 in Unit 7615 – Transportation Clearing.

Unit 7615 has currently met this budget in line item 78 and anticipates that an additional ~\$200,000 will be needed to cover expenses throughout the remainder of 2022.

Funds for this will be transferred from a vacant Auto Mechanic position in unit 7615 - Transportation Clearing that has not been filled in 2022 as well as money available in unit 7510 - General Expense under Line Item 10 - M iscellaneous. Unit 3070- Facilities has additional funding from salaries and fringe benefits which will be used as well to cover the overall transfer.
