Subject: 2022 O&M Budget Transfer of Funds Unit 1015, Van de Water WTP – Line Item 13 Chemicals

The Engineering Department is requesting the transfer of funds to the Van de Water WTP Operating and Maintenance Budget to cover the increase in overall chemical supply costs.

The scale of the unit price increases on bids received for chemicals, specifically the significant increase in the cost of chlorine, were not anticipated at the time of the approval of the original 2022 O&M budget.

In total we are requesting a transfer of \$110,000.00 to Unit 1015, O&M Budget Item 13, Chemicals.

Funds for this transfer would originate from Unit 1015 O&M Budget Item 2, Labor (\$80,000.00), Item 38, Studies (\$20,000.00), and Item 39, Payment to Contractors – Outside Labs (\$10,000.00).

Sufficient funds will remain in these accounts to cover expenses through the end of the 2022 budget year.
