The Amendment is to extend the Contract duration until January 31, 2023.

On May 19, 2022, the Authority and the Supplier entered into a materials and supplies contract (the "Contract") for the Authority's purchase of certain large diameter Hymax couplings. The original contract was to remain in effect until all materials or supplies are delivered or until August 30, 2022, whichever was sooner. However, supply chain issues relative to the Covid-19 pandemic have caused delays and the Supplier has requested additional time to deliver the Hymax couplings to the Authority. Based on the latest materials delivery schedule the vendor has indicated that all previously ordered materials will be delivered prior to January 31, 2023 and as such the Engineering and Line Maintenance Departments request that the Board approve an extension to the existing contract.

It is anticipated that all funds required for this contract will be expended in 2022 however the proposed 2023 budget also includes fund for materials and supplies that can be used if necessary.

AMENDMENT NO. 1 TO THE CONTRACT TO FURNISH AND DELIVER LARGE DIAMETER HYMAX COUPLINGS

AMENDMENT, effective October 20, 2022, to the Materials and Supplies Contract entered into on May 19, 2022, by and between

ERIE COUNTY WATER AUTHORITY

hereinafter referred to as the "Authority," and

K&S CONTRACTORS SUPPLY, INC.

1971 Gunnville Road Lancaster, New York 14086

hereinafter referred to as "Supplier."

WHEREAS, on May 19, 2022, the Authority and the Supplier entered into a materials and supplies contract (the "Contract") for the Authority's purchase of certain large diameter Hymax couplings; and

WHEREAS, in accordance with Article 5, § 5.02 of the Contract, the parties may amend the Contract by written amendment; and

WHEREAS, supply chain issues relative to the Covid-19 pandemic have caused delays and the Supplier has requested additional time to deliver the Hymax couplings to the Authority;

NOW, THEREFORE, in consideration of mutual promises herein set forth, the parties agree to the following:

- (1) The terms and conditions of the Contract shall continue in effect until January 31, 2023;
- (2) § 1.02, paragraph A of the Agreement is amended to state: "All Couplings shall be delivered to the Authority's Service Center located at 3030 Union Road, Buffalo, New York prior to **January 31, 2023**"; and
- (3) § 1.03 of the Agreement is amended to state: "This Agreement shall remain in effect until all materials or supplies are delivered or until January 31, 2023, whichever is sooner"; and

- (4) § 3.02 of the Agreement is amended to state: "The Supplier shall deliver all materials and supplies as ordered by Authority personnel no later than January 31, 2023. The Supplier's failure to timely deliver an order shall constitute a material breach of this Agreement for which the Authority may seek and recover damages, including attorney's fees and other expenses"; and
- (5) The Authority has not waived any of its rights to seek and recover damages from the Supplier for failure to timely deliver the Hymax Couplings pursuant to the dates agreed upon under this Amendment; and
- (6) This Amendment may be executed in counterparts, each of which is deemed an original, but all of which together are deemed to be one and the same agreement.
