The project also includes installation of a new room within the pump station to house new VFDs, demolition and replacement of the HVAC system within the pump station, demolition and replacement of large diameter yard piping, valves, and appurtenances, and modifications to the sanitary sewerage system. All supporting civil, structural, plumbing, electrical, and instrumentation work is also included in the project.
