**RELEASE AND INDEMNIFICATION AGREEMENT
FOR TEMPORARY WATER SUPPLY**

Agreement by and between _____ (name) hereinafter referred to as "Host/Owner" of _____ (Host property service address) and _____ (name) hereinafter referred to as "Recipient/Owner" of _____ (Recipient property service address).

Whereas Recipient/Owner's water service has been temporarily interrupted, and Host/Owner and Recipient/Owner have agreed to enter into an agreement to provide water to Recipient/Owner property above identified, therefore, the parties agree as follows:

TERMS:

Host agrees to provide water to Recipient by connection of an installed potable hose from Host property hose spigot to Recipient's hose spigot, such connection shall be provided and accomplished by employees of the Erie County Water Authority (ECWA). Recipient shall be responsible for maintaining a small stream of water running through the connection to minimize risk of freezing of the connection between Host and Recipient properties.

RELEASE:

Host and Recipient agree to release each other and ECWA from any harms and losses associated with any claims arising out of this agreement.

INDEMNIFICATION:

Recipient shall indemnify and hold harmless the Host and ECWA from all damage, loss, and cost which result from or are associated with receipt of the water provided under this agreement.

TERMINATION:

Host or Recipient may terminate this agreement upon five (5) days' written notice. ECWA may terminate upon reasonable notice or upon restoration of service to Recipient.
